



# Uninsured Attendee Waiver Form

This form is to be completed and signed by adult attendee or parent/guardian of minor attendee and attached to activity registration/application.

I understand that because I am not a Girl Scout member, and/or this activity is not intended for my participation, and/or I will not be supervised by an approved and designated Girl Scout group, I will not be covered under GSUSA's Mutual of Omaha insurance policy.

Therefore, I assume full responsibility for all risks arising out of, related to or connected with my or my child's/children's attendance in the activity. In consideration of the Girl Scouts of Hawai'i allowing me and/or my child/children to attend this activity, I, individually and or on behalf of my child/children, agree to release, indemnify and hold harmless the Girl Scouts of Hawai'i and its officers, directors, employees, agents and volunteers from all liabilities and claims for any injuries, losses, death, damages or costs (including reasonable attorney's fees) which arise out of or incident to my or my child's/children's attendance in this activity.

The Uninsured Attendee Waiver is completed by an individual participating in a Girl Scout activity who is not Girl Scout member and who is not covered under GSUSA's Mutual of Omaha insurance policy. The participant (adult) or participant's guardian (minor) must complete an Uninsured Attendee Waiver each time s/he participates in a Girl Scout activity. To be eligible to complete an uninsured attendee waiver, the participant must meet one of the following criteria:

1. Is participating in a Girl Scout activity that is not intended for the individual's participation and will not be supervised by an approved and designated Girl Scout group and who will not be covered under GSUSA's Mutual of Omaha insurance policy.
2. Is participating in a Girl Scout activity that is intended for non-Girl Scout members (i.e. recruitment event, friends and family event, etc.). In this circumstance, it is recommended that Council, Service Units, or troops purchase Plan 2 insurance for the activity before pursuing the use of Uninsured Attendee Waivers.

Is a girl participating in Council, Service Unit, or Troop activities after August 1<sup>st</sup> of the current membership year and before October 1<sup>st</sup> of the next membership year. This waiver must be collected for each activity in which the individual participates. In this circumstance, it is recommended that Council, Service Units, or troops purchase Plan 2 insurance for the activity before pursuing the use of Uninsured Attendee Waivers (See **C06 S06 Volunteer and Girl Placement**).
